I personally would like to thank the Membership of Local 157 for the confidence they have shown in me by electing me Business Manager. I do pledge a commitment to work hard and perform my duties with integrity and honesty, without bias, and with fairness to all.

The month of December was tough on our Health & Welfare. After receiving two substantial invoices, one for \$762,908.33 and one for \$766,022.98, our Administrative Manager had to remove \$2,000,000.00 out of investments and into the operating account.

Recently everyone received an annual report for the Pipe Trades Industry Health & Welfare Plan and I have had questions about administrative expenses. This amount is inclusive of the following expenses:

These are most of the larger ones. Hope this gives some insight to this cost.

I will have a meeting with the Board of Trustees for the Health & Welfare Plan on January 27<sup>th</sup> and will have more to report on at the February Union Meeting.

## **Business Agent's Report**

### **Wilbur E. "Webb" Crouch III**



As of this publication there are 235 Journeyman and 62 Apprentices actively seeking employment with 141 members on travel jobs. For the month of November we dispatched 110 Journeyman and 23 Apprentices with 37 call backs and 44 members to travel jobs. For the month of December we dispatched 99 Journeyman and 13 Apprentices with 17 call backs and 56 members to travel jobs.

Freitag & Weinhardt was the successful bidder on the flare gas recovery project at Marathon. They are anticipating the field work to start the first of March and will hire approximately 20 pipefitters, working a 4-10's schedule.

The Merom spring outage is scheduled to start the second week of March. Sterling Boiler will hire approximately 18 pipefitters for 3 weeks of 6-10's and then work 5 weeks of 5-10's. For this outage Freitag will hire approximately 40 pipefitters for 6 to 8 weeks of 5-10's then have a 2 week lull and start work again for 10 days of 12 hour shifts.

The water treatment project at Cayuga Powerhouse is off to a slow start due to weather and unforeseen issues. Once things clear up they will be hiring more people.

ICS was awarded a one year extension on their contract at Edwardsport. A big thank you to all who worked on the fall outage at Edwardsport and helped to make it a success, despite all the hurdles and confusion on this project.

Also I would like to thank each and every member who is out in the trenches every single day trying to hammer out a living for their family and working for the betterment of Local 157. Your hard work and dedication is what sets us apart from the non-union element.

Congratulations to all the newly elected officers of Local 157. I am looking forward to working with all of you to help lead our great organization into a prosperous new year.

Tiny was also step-father to my two cousins Jimmy and Danny Bays. I want to believe he would be pleased. As time goes on, I hope to please our membership also. Thank you all.



## Field Representative's Report

### Steve Snyder

It has been a very busy last few weeks in the Greater Lafayette Area. I have been able to close out a lot of pending items.

One of the longest ongoing issues has been the amendment to the Responsible Bidders Ordinance for the City of Lafayette. After nearly an 8 month process which involved dozens of hours of my time as well as other labor reps time, I am happy to report that the proposed amendment to the City of Lafayette's existing Responsible Bidder Ordinance on its second and final reading passed unanimously 5-0 during the most recent Common Council meeting. This amendment will give the City of Lafayette's Board of Works more tools to use in determining contractors for city projects. Among other things it mandates information from contractor's concerning employee classification, drug testing and certified payroll requirements. This amendment will help our union contractors be more complete in the future.

I had the opportunity to meet with DA Dodd's lead supervision to go over plans for a Local 157 based UA fabrication facility. A building has been purchased with a little over 25K square feet. I have introduced and reviewed the UA Fabshop Agreement with DA Dodd and have contacted the International Rep for approval once move-in is complete in February. They plan on making a big splash with the Greater Lafayette Chamber of Commerce which will include a ribbon cutting ceremony. I will report on that once the date is pinned down. Currently DA Dodd is going to start on pre-fab for several jobs at Purdue and Saint Elizabeth Hospital. After received accreditation from the UA, plans are in the works for Local 157 Members at this new fabshop to start fabrication piping on the new Four Winds Casino that will be breaking ground spring of 2017 in Local 172 jurisdiction. I do not have all the numbers yet, but fabrication for this project will equate to thousands of hours for our local Members regardless of the destination. I look forward to Local 157 being part of the success of this endeavor. As you already know when our contractors do well, we do well.

I have had a chance last week along with the President of the Tippecanoe Building Trades to meet with Lafayette School Corporation Superintendent Les Huddle to review the over 98 million dollars' worth of work for the next two years. One of the largest mechanical packages is a 22 million dollar design build project on Jeff High School along with a new elementary school and additions to Tecumseh Middle School. While Les is a kingpin in the entire process of contract awards he answers to the school board. Currently I and the Tippecanoe Building Trades President have a meeting with the school board President to discuss options on contract awards and labor specifications for the upcoming Work.

Purdue University work continues despite the bitter cold setting in. Several interior lab remodels are ongoing as well as the larger project the new Animal Life Science. I don't expect at this time manpower to increase due to this cold snap. Hopefully it will be short lived.

Evonics has finally picked up on the capitol project side of things. Currently Freitag & Weinhardt is working on phase one and two of six remodels to T29. I have prejobed phase one and they are currently maxed at peak manpower at 12 PF's. This will change dramatically pending the release date, competition and scope of the other 4 phases. Currently phase one is scheduled for 4X10's and phase two 5-8's.

A lot of buzz has been generated by a recent press release about proposed 350 million dollar energy plant in Carrol County titled "Project Lego". GEP Fuel & Energy Indiana made the announcement and submitted conceptual drawings of the Diesel Refinery which is located on 80 plus acres of land along the Northside of SR. 75 near Camden, Indiana. The Indiana Economic Development Corp. has granted up to 2 million dollars in conditional tax credits. On December 14<sup>th</sup> at 8:30 am the Carrol County Council held a special meeting to approve local tax credits and rezoning of the planned development site. Neither one of these resolutions passed the council due to lack of specifics requested by the public and council members. Typically a project of this size and scope before a press release has ran the gamut of several behind the scene processes including re-zoning, air permit applications, land acquisitions and soil testing. This project has not completed a single one of these steps. Typically I get a whiff of

these projects brewing from people I deal with in the economic circle. This particular project has completely come from thin air which leads me to believe that this press release was designed to spur investor interest. After doing some homework I did in fact discover that no funding for this project has been raised to date. Do not hold your breath on ground breaking.

I am happy to report that the SIA outage and Arconic (ALCOA) outages went off without a hitch. Several contractors had work during the holidays. Some more than others, however there was Local 157 Pipefitters onsite day and night over the holidays at both locations. As we know we are compensated very well for our time but it all comes at a personal cost and sacrifice that we make by being away from our families. To those who gave up their time with their loved ones to keep SIA running at full speed, and to keep Arconic (ALCOA) presses online I want to personally thank you and commend you for your dedication. Members like you are the backbone of this Local.

In closing I would like to congratulate all of our newly elected officers. I am glad to see we are over this campaign and that focus once more can be sharpened for the task at hand which of course is putting our Members to work. May everyone have a prosperous new year.

## Field Representative's Report

### David Hoopingarner



I want to start by congratulating all the newly elected officers and wish them the best!

In 2017 we are expecting a busy year in the Gas Distribution Division. There are many projects on the horizon, with several travel jobs in the state and tristate areas.

Evansville (Local 136) at Petersburg, IP&L has a bottom dry fly ash job that will be hiring at the end of January. Also, in February a shutdown is scheduled to run for 50 days and a week off and then running another 50 days. Downtown Evansville is building a new hotel and a new IU Medical Center.

Duke Gibson Powerhouse has dry fly flash and water treatment projects starting in February that will last up to a year. AEP Rockport is still hiring with 3 months left on the project before completion.

In Bloomington, Indiana at Indiana University, dorm renovations have started, lasting up to 5 months. Also in Bloomington this spring they are building a new \$350 million hospital and a new hotel.

Indy (Local 440) still has work at Stouts Powerhouse that will be finishing up in April.

Martinsville out of Indy, will be hiring in the near future for construction on their Powerhouse. 440 also has two hospital projects coming up and a McAllister expansion, as well as a Pacers Practice Facility renovation.

Owensboro, KY (Local 633) has a TVA dry fly ash job and water treatment plant expected to last up to 2 years. They also have a fall outage running 110 days of 6/10's. Paducah, KY (Local 184) will be hiring late January getting ready for a shutdown that starts in March at Westlake Chemical Plant running 50 days. They will have a large project coming up running out of Calvert City.

New York (Local 373) Rockland County Powerhouse, contractor is ICS, has a long term project lasting 9 months working 5/9's and an 8 with the scale being \$38.70.

Cincinnati, OH (Local 392) has a peaking unit breaking ground late January or early February. Canton, OH (Local 94) with contractor Bechtel, has a long term project working 5/10's with the scale being \$37.87.

Rockford, IL (Local 23) has a nuclear outage scheduled for February working 6/10's for 40 days. Background checks will be required and PHQ's will be done on site. Rock Island, IL (Local 25) at Nelson Powerhouse will be building 2 new units early summer. Scale is \$38.75 working 6/10's.

Alton, IL (Local 553) has a scheduled shutdown at Phillips 66 running 30 days, hiring in February. Belleville, IL (Local 101) has a shutdown at Lively Grove starting in mid-February, working 6/10's for 40 days with the scale being \$38.40.

Kalamazoo, MI (Local 357) has a Palisades Nuclear Powerhouse outage starting mid-March running 30 days. Ann

During the months of October and November 2016, your Health and Welfare Plan staff processed 15,750 claims, totaling \$6,406,356.30.
