Business Manager's Report

Mark W. Swaner

Since my last column, we have been very busy with attending Tennessee, Illinois and Indiana Pipe Trades. These meetings are essential to form relationships in and learn what is coming up in our area. In the last week of February through the 3rd of March I attended the newly elected business managers school. This seminar was packed full of information, from fiduciary responsibilities to defined benefit and defined contribution, retirement programs to health and welfare and educational trust funds.

In talking with all of the new business managers from all over the United States and Canada with locals that are HVAC, plumbing strong to commercial and industrial locals like ours. The story is about the same. The economic down turn in 2008 had a devastating effect on the construction industry. Most, if not all UA locals lost membership due to the down turn, not to mention the mass retirement of our baby boomers. This causes a multilayer problem. First, with our health and welfare that has more retirees than ever before and less active membership to support the fund. This with the cost of affordable health care has been the major reason for the 90-cent contribution raise in 2016 and our projected one dollar contribution raise in 2017. At the February meeting there was a question about Medicare Part D Prescriptions with United Health care premiums. The best way to explain this is from a monthly member cost, that is \$208,853.10, with a total savings of \$54,496.50. This is an example from last December. There has been a lot of questions about health and welfare and the possibility of having Tim Thacker at our union meeting to give a more defined report. After speaking to Tim and finding out about the rules set forth by the trustees, the pipe trades health and welfare cannot have the plans administrator in an official capacity at a local union meeting. But in our April trustees meeting, I will get permission to set up a special health and welfare meeting, not during a Local 157 union meeting. At that time Mr. Thacker will answer all questions related to health and welfare.

One good thing is the Midwest and pretty much the entire United States is in the midst of a construction boom. This is why in the past year and a half you're hearing so many robo calls, with travel jobs everywhere. This has been good for Local 157 because our industrial work has been down. We hope and it does look like in the next year or so industrial work is going to make its way back to the jurisdiction of Local 157.

In closing I would like to let the membership know that on March 29th and 30th, our Local 157 Apprentices will be competing in the State Apprenticeship Contest. On Saturday April 8th, here in Terre Haute there will be an Easter Egg Hunt, registration is at 10:30am.

Business Agent's Report

As of this publication there are 148 Journeyman and 33 Apprentices actively seeking employment with 174 members on travel jobs. For the month of January we dispatched 134 Journeyman and 43 Apprentices with 38 call backs and 73 members to travel jobs. For the month of February we dispatched 89 Journeyman and 20 Apprentices with 25 call backs and 58 members to travel jobs. It appears that work will be slow in our jurisdiction this summer (with the exception of the Lafayette area). Fortunately sister locals are employing many Local 157 members.

By the time this reaches you the Merom outage should be in full swing with Freitag & Weinhardt and Sterling Boiler employing approximately 60 of our members. I anticipate Freitag to be hiring a few members in late March or early April for the Flare Gas Recovery Project at Marathon. Skanska will be hiring more of our people throughout March and April for the Water Treatment Project at Cayuga Powerhouse. From information I have received from several sources, the S&G Fertilizer Conversion Project will not start until at least the middle of 2018. The Tuscola Fertilizer Plant is still moving forward but at a very slow pace. The state budget being held up has had an effect on the infrastructure necessary for this project. There is still some discussion at Newport about the possibility of a Combine Cycle Plant being constructed there but nothing has been signed and the details are being kept quiet.

There is a lot of uncertainty, politically, at the state and federal levels of government. The State of Indiana has a Republican controlled House, Senate and the Governor's seat, while in Illinois the Democrats have held onto the House and Senate but have an anti-working class Union bashing Governor who continues to hold the State budget hostage. At the Federal level the Republicans have the House, Senate and the Donald who has been quoted as saying, "The point is, you can never be too greedy" and "The beauty of me is that I'm very rich." No one knows in what direction our country is headed, not even the POTUS which leaves the construction industry unsure of what move to make next. That being said, many of the potential, major construction projects in and out of our jurisdiction are moving very slowly or not at all at this time. Enough about politics.

I would like to congratulate our Apprentices Justin Swartz, Tim Biddy, Joe Sparks and David Morgan for winning our local Apprentice Competition in their respective categories. I wish them good luck at the State Competition to be held at Local 157 Training Center on March 29th & 30th and urge all members to come out and support them.

The Annual Kids Fishing Rodeo is tentatively scheduled for June 10th. Look for all the details in the May/June paper.

Financial Secretary Treasurer's Report

This past month Mark, Webb and I have attended Pipe Trades meetings in Tennessee, Illinois, and Indiana. We have also attended Local Building Trades meetings in Terre Haute, IN, Danville, IL, and Effingham, IL. At some of these meetings Mark and I introduced ourselves to other Trade Representatives, many new like us, other times we were just re-associating with old friends. Luckily Webb has good relationships everywhere we have gone.

These Building Trades Council meetings allow us to gather information collectively for the latest on up-coming jobs. For example we were privy to a pre-job meeting in Terre Haute. We had several contractors there talking about our up-coming Hoosier Energy Merom Powerhouse shutdown. At these pre-jobs, projected manpower numbers, duration of the job, including days and hours to be worked are discussed. As well as any special concerns, for instance, will they be accepting our drug card? Will they require a weld test or will they accept up to date U.A. Weld Certifications? Will there be a night shift? So all of these meetings we attend are important to allow us to prepare for up-coming jobs.

At our Indiana State Pipe Trades meeting we were re-introduced to International Representative Dave Posey. The last

several years Brother Posey has been the U.A.'s International Representative for the states of Tennessee and Kentucky. As of January 1, 2017 he has been leading Indiana and Kentucky. Brother Posey is the former Business Manager of Local Union 440 of Indianapolis, IN and a longtime friend of Local Union 157. We all wish him the best!

Also at this meeting we were able to hear from all the other Managers and Agents about up-coming work. Another interesting report was given by Indiana State Pipe Trades Executive Director and Local 157 member Darrek Davis. Darrek keeps everyone informed on the latest political moves coming out of our Indiana Statehouse. He had several details relating to our Indiana elections from 2016. Darrek does a great job keeping us up to date.

At our Illinois State Pipe Trades meeting we were introduced to our new U.A. International Representative Billy Myers. Brother Myers comes from Local Union 597 Chicago and we look forward to his leadership. This meeting was also a Legislative meet and greet. There were several Legislators in attendance, allowing us the opportunity to talk about the proposed Cronus Fertilizer Plant near Tuscola, IL. Probably our biggest concern is the state still not having a budget; hopefully this will be worked out soon.

At this meeting we were also able to hear a great speech from Chris Kennedy. Mr. Kennedy is the youngest son of Robert "Bobby" Kennedy and sounds like a legitimate candidate for Illinois Governor. Hopefully we can get behind him and get him elected.

I would like to take this time to congratulate this year's group of Apprentices who were successful in Local Union 157's Apprentice Contest and all of those who stepped up to compete.

Field Representative's Report Steve Snyder

Work in our Northern jurisdiction is starting to unfold. Hiring for construction projects should be rather robust for the next several weeks as ground breaking commences and weather improves.

The expansion of the Paint #2 system at Subaru Industrial Automotive has finally bid and has been awarded to HMH Contracting. This project has been in the works for a very long time as design and financing has progressively delayed this project for several months. I have yet to pre-job this project so scheduling and manpower requirements are not quite known at this time. Along with this expansion, work continues on maintenance and capital improvement projects keeping several of our union mechanical contractors busy during production and off production times.

The proposed \$350 Million dollar Bio Diesel Plant has not made any significant progress since my last report. I was able to find out that Briner Construction has been retained to act as the Construction Manager for this project. Briner is based out of Bluffton, Indiana and is a Butler Building Dealer who specializes in large metal building.

Institutional work for this summer has been very abundant throughout Benton, Clinton, Montgomery, Tippecanoe and White Counties. The Lafayette School Corporation make ready package for Tecumseh Middle School has become available for bid. The bid opening date is scheduled for March 16th. This is the kickoff of the 90+ million dollar investment being made throughout the school corporation including a 22 million dollar HVAC upgrade at Jefferson High School and a \$15 million dollar brand new Glen Acres elementary school. I will be following these bid packages as they develop over the coming months ahead. I was recently informed that Johnson Melloh Contractors were the apparent low bid for the \$22 million dollar new West Lafayette Elementary School. This has been in the works for several months. The need has been great and West Lafayette School Corporation has put forth quite the effort to get this project off the ground. I will know the manpower requirements and scheduling once a pre-job has been completed. The Benton Central High School remodel and lab remodel has been bid and it appears that Quality Plumbing and Heating was the apparent low bid. In White County the Twin Lakes and Monticello School renovation projects were both bid and awarded to Benchmark Mechanical and are scheduled to start in May of this year.

Our heavy industrial work continues to be a main staple. We have union mechanical contractors working in several plants both during peak production and non-production times. We have contractors in Wabash National, Alconic, Evoniks, Industrial Plating, Fairfield Manufacturing, Ray Magnet Wire and

of course Subaru Industrial Automotive. In the last three years I have witnessed an increase in manufacturing using our skilled labor more and more. I expect this trend to increase as time goes forward.

The T27 project at Evoniks is currently at peak manpower. Freitag and Weinhardt have been working on this capital improvement project for several weeks. Currently both day and night shifts have been working six days a week and will continue as engineering and design lag behind.

I attended my first United Way of Greater Lafayette Board of Directors meeting last month. It was a very candid and comfortable setting. I recognized and have had good relationships with the majority of the Board members. I look forward to being part of the conversation going forward. To those who voted me in to this position, I want to say thanks for the confidence and opportunity.

The "Third House" with the Greater Lafayette Chamber of Commerce is in full swing. I signed up as a labor representative through the Tippecanoe Building Trades Council. This "Third House" is designed as a forum for community leaders to meet with State Senators and Representatives. They meet every other Saturday morning from 7:30am to 9:00am. If anyone is interested in attending these meetings let me know. They do have a guest table for the general public with plenty of room.

It's that time of year again for the annual Local 157 Golf Outing. It will be held at Rocky Ridge Golf Course on Sunday, August the 20th. See the flyer on page 10 for further information. I hope to see you there!

I'd like to start off with Gas Distribution Division Pipeline Contractors Reports and hours.

Work in Evansville at Petersburg, IP&L bottom dry fly ash has started as well as the shutdown at IP&L Petersburg. The shutdown is scheduled to run 50 days and a week off and then running another 50 days. Also, downtown Evansville is building a new hotel and a new IU Medical Center. Duke Gibson Powerhouse has started a dry fly ash and water treatment. Princeton Toyota is planning an expansion this summer. AEP Rockport has 2 months left on their project before completion. Indiana University in Bloomington, Indiana has started dorm renovations to last up to 6 months. Also in Bloomington this summer a new 350 million dollar hospital and a new hotel are to be built.

Indy still has work at Martinsville lasting up to 6 months. Indy also has two hospital projects coming up and a McAllister expansion as well as a project at Lilly's. There is also work to be done on schools this summer and a Cummins expansion.

Owensboro, KY (Local 633) has a TVA dry fly ash and a water treatment plant expected to last up to 2 years. They also have a fall outage running 110 days of 6/10's. Paducah, KY (Local 184) will be hiring mid-March for its shutdown at Westlake Chemical plant.

Cincinnati, OH (Local 392) has a Peaking Unit breaking ground mid-spring to early summer. Canon, OH (Local 94) with contractor Bechtel has a long term project working 5/10's with scale being \$37.87/hour. Marietta, OH (Local 168) has a shutdown at a powerhouse in May lasting 45 days. Columbus, OH (Local 189) Honda Car Plant will be having an expansion starting in May and is expected to run up to a year. Lima, OH (Local 50) has a shutdown scheduled late March at BP Refinery lasting 90 days of 6/10's.

Rockford, IL (Local 23) has a nuclear outage scheduled for March working 6/10's for 40 days. Rock Island, IL (Local 25) at Nelson Powerhouse they will be building 2 new units early summer. Scale is \$38.75/hour working 6/10's. Alton, IL (Local 553) has a shutdown scheduled at Phillips 66 running for 30 days. Belleville, IL (Local 101) has a shutdown at Lively Grove starting in March working 6/10's for 40 days with the scale being \$38.40/hour.

Nashville, TN (Local 572) has a job at Arnolds Air Force Base working 5/10's. They also have a GM Plant expansion which will be a long term project.

Milwaukee, WI (Local 601) has a peaking unit being built and a Buck's Basketball arena is to be re-built. Ohio work will last over a year.

Reno, NV (Local 350) has a car battery plant working 6/10's for 3 years.

I appreciate the opportunity to serve the Members of Local 157 and have had the opportunity to meet and build a relationship with many local representatives, therefore if you know of any jobs around the country that you are interested in I would be happy to make contact with them and see what's available.

It is very important that you know who your beneficiary(s) are for the Death Benefit under the Plan. The Plan provides a Beneficiary Form that needs to be completed when you become covered under the Plan in order to name the Beneficiary(s) to receive your Death Benefit. The Beneficiary Form is also used to change your beneficiary(s). You may want to change your beneficiary(s) in the case of marriage, divorce, or the death of the named beneficiary(s). If you have not completed a Beneficiary Form or you need to make a change, please contact the Plan office and we will mail you a new Beneficiary Form. Please note that any change of beneficiary shall not be effective until received by the Plan provided such change is received prior to the death of the eligible participant.
