

OFFICIAL CONVENTION CALL



TO ALL OFFICERS AND MEMBERS OF UNITED ASSOCIATION
LOCAL UNIONS AND STATE OR PROVINCIAL ASSOCIATIONS:

Dear Brothers and Sisters:

In accordance with Section 11 of the United Association Constitution, we, your General Officers, hereby issue the call for the Thirty-Ninth Convention of the United Association of Journeymen and Apprentices of the Plumbing and Pipe Fitting Industry of the United States and Canada, AFL-CIO, to convene Monday morning, August 1, 2016, at 8:00 a.m. in the San Diego Convention Center, San Diego, California.

Local Unions and State or Provincial Associations shall proceed to elect delegates and alternates in accordance with the provisions of the United Association Constitution governing this all-important subject. Among the provisions of the United Association covering the convention and election of delegates are those listed below:

SEC. 11. Regular conventions of the United Association shall be held once every five (5) years. The date, time and place for holding the convention shall be set and established by the General Executive Board. The General Secretary-Treasurer shall notify all Local Unions as to the city designated where the convention will be held and the date the convention will open.

SEC. 12. The basis of representation of delegates to each convention shall be one (1) delegate for each Local Union, provided that said Local Union shall not have less than twenty (20) members in good standing during the fifth full month [March 2016] immediately preceding the month in which the convention is to be held, and one (1) delegate for each additional one hundred (100) members.

SEC. 15. All delegates to the convention shall be elected by secret ballot. Nomination of delegates shall be held by a Local Union at least twenty-five (25) days prior to the election. At least ten (10) days prior to the nomination meeting, notice shall be mailed to the last known address of all members in good standing of the Local Union setting forth (1) the date and place of the nomination meeting, and stating that delegates to a convention will be nominated at the meeting; (2) the notice shall also state the date, time and place of the secret ballot election of delegates to the convention; and (3) the notice should state also that in the event of a tie vote and a runoff election is necessary, then the date, time and place of the runoff shall be so stated. Protests of an election of delegates to the United Association Convention shall be processed under the provisions of Section 125 of this Constitution.

SEC. 16. The candidate or candidates receiving the highest number of votes in the delegate election shall be declared the elected delegate or delegates. The candidates receiving the next highest votes shall be the alternates, by descending numerical order, and shall act in the case of the inability of any regular delegate to attend the convention.

SEC. 17. No member shall be eligible as a delegate or alternate unless he shall have been a good standing member of the Local Union which he is to represent for at least the two (2) continuous years previous to his election and he remains in good standing from the date of his election through the period of the convention.

SEC. 18. The duties of weekly salaried elected officers of Local Unions shall also include serving as a delegate to the United Association Convention for his Local Union.

SEC. 21. Each delegate shall be entitled to one (1) vote (this to include State and Provincial Association and District Council delegates also).

SEC. 23. The expenses of delegates of the United Association Convention shall be defrayed from the Convention Fund of the United Association upon the following basis: each delegate shall be paid the standard rate of wages in his home town, and an expense allowance for the maximum of one (1) day's travel to the convention site, for a maximum of one (1) day's travel from the convention site to his home, and for each day the convention is in session. Each delegate shall also be paid his round trip transportation based on regular coach air fare from the city where his home Local Union is located to the convention site by the shortest route. The expense allowance shall be \$150.00 per day. In the event any portion of the expense allowance or transportation allowance is not expended it shall be considered as compensation.

Delegates must reach San Diego, California, in time for the opening of the Convention on Monday, August 1, 2016, at 8:00 a.m.

The delegates are requested to bring to the convention their individual dues card, Social Security or Social Insurance card, and a driver's license or photo ID.

Business Manager's Report

At the October 30, 2015 Union Meeting the Membership approved putting the \$.30 rate increase, as per our current collective bargaining agreement, on wages. The wage increase takes effect January 1, 2016.

We will be having Delegate nominations for the 39th UA Convention on February 5, 2016. The election will then be held on March 5, 2016. This is a great opportunity for solidarity with UA Members from all over the U.S. and Canada. It also is a great way to learn more about our great organization and participate in its Constitutional process. Having it in San Diego this time will also provide a very family friendly environment. Because of the timing of nominations, contained in this newsletter is your official notification. We will not publish a newsletter in January. We will have one in February after nominations to allow all nominees to place an ad for the election of Delegates.

You should have recently received a mailing from the Indiana Pipe Trades Defined Contribution Pension Plan. This Plan has been working very well for our Membership. Included in the mailing was a section on "Frequently Asked Questions". This was put together very well and should answer most of your questions and if you have other questions please contact the IPT Plan office. Also, it contained a form to request a new 401(k) booklet. If needed please complete the form and mail it to the Plan office.

The first week of November was National Apprenticeship Week. Apprentices are employed by 150,000 employers. There are over 400,000 registered apprentices in more than 1,000 occupations. Those who have completed an apprenticeship earn an average of \$300,000 more during their career than those that don't. For every dollar spent on apprenticeships the employers get an average \$1.47 back in increased productivity. The JATC has recently hired Jeff Ehrlich as the Welding Coordinator and Mike Smelser as the Assistant Training Coordinator. We believe we have an outstanding Training Program and the addition of these two, with our Training Coordinator Rich Cheever and all of our Instructors, we will continually improve on our long standing tradition of excellence in training.

The Cronus Chemical Fertilizer Project in Tuscola is continuing to make slow progress. They have obtained all of the land rights to install the water line to the site. They also have secured the necessary permits and are finalizing the financing. The expected start for construction is late in the 2nd quarter of next year. We understand with the way this project has progressed it may get a later start. When this project does get underway there will be a large demand for certified welders. We want to encourage those without those skills and those that may need additional certs to take advantage of our weld shop.

We recently observed Veterans Day as a reminder to thank all of those currently serving and those who have served in our Military to protect our freedom. I want to give a special thank you to all of our Veteran Members.

I hope everyone gets to relax and spend time with family this coming Holiday Season.

As of this publication there are 226 Members actively seeking employment with 39 of them being apprentices and 33 Members on travel jobs. For the month of September we dispatched 103 journeymen and 26 apprentices with 12 call backs and 32 Members on travel calls. For the month of October we dispatched 103 journeymen and 27 apprentices with 19 call backs and 26 Members on travel jobs.

Work in our jurisdiction continues to slow with winter impending. We have been very fortunate that our sister locals have been and will be flush with work for a while and they have kept many of our members working when our work is slow.

As I reported last month the Newport Vermillion rise site is still working away on infrastructure improvements. Recently River View Energy, as some of you may know, has filed with the Indiana Department of Environmental Management for an air permit for the Newport site. Depending upon the air permit approval, construction could begin in 2019 on their coal hydrogenation facility.

It appears the fertilizer plant in Tuscola, Illinois should start construction the 2nd or 3rd quarter of 2016 if all goes well.

I would like to remind everyone to be sure we have your latest phone number, address, etc. on file so there is no delay in reaching you for job opportunities.

If anyone is aware of a travel job they would like to go to call me at the office and I will try to get you dispatched.

To all the deer hunters, good luck and be safe this season. If you have any hunting pictures, send them in and we will try to get them in the next paper.

Financial Secretary Treasurer's Report

There always seems to be questions regarding union dues payments. With a new year fast approaching, I hope to answer some of those questions with a brief over view of our system.

According to our bylaws (Section 29) "Dues for members of the Local Union shall be the minimum provided in the United Association Constitution and shall be paid on a quarterly basis." Section 29 also states members owing over 3 months dues shall be suspended without notice of any kind, denied all rights, privileges and monetary benefits, and shall pay a \$50 reinstatement fee. Any member owing 6 months dues will be expelled and pay a new initiation fee. Our bylaws also make special arrangements for Metal Trades members who have a check off agreement. Dues for 2016 are \$87 per calendar quarter beginning January 1st.

We have tried to make it convenient to verify your current dues status as well as pay your dues. We accept 4 forms of payment... cash (in person), check, money order, or credit card (Visa and MasterCard ONLY).

You can verify dues status by simply calling the job line at (877) 967-5157 and putting in your U.A. membership card number or the last 4 digits of your social security number. The first thing you will hear is your dues paid through date. You can also go to our website at www.ualocal157.org and log into the "member's only section."

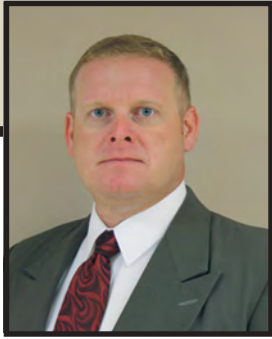
To log into the members only section, the username is your U.A. membership card number and your password is your birthdate in this format..MMDDYYYY..all digits, no dashes, or slashes. Once you log in, click on the "pay online" icon. You can then check the months to pay for which includes a 2% "check out" bank fee, enter your credit card information and submit your payment.

You can also pay dues in person at the main office in Terre Haute. Do not take or leave dues payments at any sub office or give them to an instructor or anybody else relying on them to take on your responsibility for the payment.

Members can also mail a check or money order to the main office. We supply the "blue dues envelopes" as a convenience, but you can use a regular envelope if you need to.

Paying your dues on time and keeping them current prevents problems for you and your union.

Field Representative's Report Darrek Davis

Not much has changed since my last article. Work continues at the REG Bio diesel facility in Danville. We will see hiring increase sometime after Thanksgiving, with the manpower peaking around 60.

Talks have already begun about the March turnaround at the Marathon Refinery. Early numbers show Morris Construction needing approximately 240 pipefitters. It is scheduled to be working 7-12's for 40 days. One thing that will be new for this turnaround is Marathon will be implementing the new OSHA fatigue policy, this will only allow someone to work 14 days straight and then they are required to take 1 day off. It

has yet to be determined as to how this will be managed and as far as what day an individual will be scheduled to take off. I will keep everyone informed as the details are worked out.

As we see our work slow down in the winter months it would be a great time to come in and utilize our training facilities. Welders continue to be in high demand and this is a trend we will continue to see for years to come.

Our challenge going forward remains the same: properly manning jobs with the appropriate skill sets so that the contractors can continue to be competitive. Remember each day, you are the union and the whole industry is watching. We must continue to work every day as if our livelihood depended on it, because it does! Never let a day go by without realizing that our 157 family is so privileged to have a fantastic wage package, great health care and a liveable pension, unlike others from the non-union side. But that privilege does not come without a price. That cost must be offset with our managerial skills, production rates, attitudes, enthusiasm and our commitment to quality every hour of every day. When we follow that simple recipe for success everything else will fall into place and we will continue to be the best value for the price.

Field Representative's Report Steve Snyder

Work for the fourth quarter in the Northern area remains firm and should stay this way through the winter months.

The Subaru paint shop addition is starting to come to a close as substantial completion is right around the corner. H&R Mechanical Contractors are still working on the last piece of the phosphate system. Currently they are working two shifts 6-10's until the end of November. The remaining contractors are tying up loose ends and completing punch list items. There are still a lot of scope gaps that need to be

awarded and completed by the owner. I expect at any time additional work to become prevalent as startup begins.

Purdue work continues at the Honors College which is starting to take off with a heavy demand for plumbers and welders. This job is only going to be limited by the weather and outside forces at this point for our members. The Active Learning Center is still a sea of rebar and concrete at this point. I am still optimistic that our work at this project won't really takeoff until the first of January 2016. As I have reported in the past this project is a complete pan deck poured rebar post and beam construction. If any of you have had the pleasure to work on this type of project you can understand the massive amount of time it takes to build a structure as opposed to red Iron structural steel.

The outages at NUCOR steel in Crawfordsville and Frito-Lay in Frankfort both went off without a hitch. Both projects finished ahead of schedule and with no lost time accidents. These are indicators of a successful project.

I reported in our last Union meeting that the Lafayette School Corporation is planning several multi-million dollar upgrades throughout the school corporation jurisdiction for the 2016, 17 school years. Among one of the projects is a 50 million dollar upgrade to Jefferson High School. Virtually every school will have some major additions or renovations in the next 2-3 years. I look forward to working with the school superintendent and school board to help get the most bang out of the taxpayers' dollars by using local skilled labor to help complete these projects.

One of my other duties is to assist the local community in various fundraising campaigns. One of the ones I am most proud of is my Chair position for the United Way division of Contractors and Building Trades. This is my second year helping with their annual campaign which ends November 14th. This particular branch of the United Way is the second largest campaign in the State of Indiana next to Marion County. It is very exciting to be a part of this campaign and to watch how their money is distributed to the 22 plus agencies that they help fund throughout the Greater Lafayette area. I have met some great community leaders sitting on this board and have made several new friends that understand our message.

In closing I want to wish everyone a happy and safe holiday. If you have the time, look for some volunteer opportunities throughout your community. Remember, if you have the ability to help someone then you have the responsibility to help.

During the months of August and September 2015 your Health & Welfare Plan staff processed 13,883 claims, totaling \$5,746,268.28.

In this article, I would like to state the eligibility rules for shop owners and self employed members.

Participation and eligibility for shop owners and self employed members shall be based upon the reporting and payment of forty (40) hours per week (thirteen (13) weeks per calendar quarter) or the actual number of hours worked in the case of a bargaining unit individual, whichever is greater. Failure to report the minimum of one hundred sixty (160) or two hundred (200) hours per month in a calendar quarter shall result in a failure to establish Initial Eligibility or to maintain eligibility. Such shop owners or self employed members must be signatory to either a collective bargaining agreement with the Union or have signed a participation agreement.

UA Convention Delegate Election Rules

Fred Reagin, who serves as Chariman of the Union's Election Committee has released the rules and regulations which will govern the election of Delegates from Local 157 to the United Association's 39th Convention that will be held in San Diego, California opening on Monday, August 1, 2016.

Rules and Regulations as established by the Constitution of the United Association, the Election Committee, and Section 24 of the Bylaws of Plumbers & Steamfitters Local 157.

1. No Member shall be eligible to vote unless they have been in good standing in Local 157 for a period of at least one (1) continuous year immediately prior to the election date.
[Laws & Bylaws Section 24 & UA Constitution Section 124](#)
2. Voting shall be by secret ballot and those candidates receiving the highest number of votes cast shall be elected.
[Laws & Bylaws, Section 24 and UA Constitution Section 122b.](#)
3. Candidates desiring to do so have the right to one observer, at the candidate's expense, at any or all polling places; that observer must also be a Member in good standing of the Local Union.
[UA Constitution Section 122b.](#)
4. Eligible Members are to present their signed Membership Card, or other photo identification; and must have their name included on the "Eligible to Vote List" provided by the United Association.

5. All persons voting must sign the "Eligible to Vote List" next to their name, in the presence of a member of the Election Committee, before receiving a ballot.

6. Members may vote for the number of designated candidates, or less. Any ballot with more votes than designated will be null and void.

7. Voting by writing the name of a person who was not nominated shall not be permitted.
[UA Constitution Section 122b.](#)
8. Ovals on Ballots must be completely filled in and any ballot signed or having other identifying marks will be null and void.

9. Local Union Apprentices are not allowed to vote.
[UA Constitution Section 148b.](#)
10. The Membership will be provided the opportunity to cast their votes in one of four polling locations on March 5th, 2016: Danville ~ from 8:00 am to 1:00 pm (CST), Lafayette ~ from 9:00 am to 2:00 pm (EST), Hutsonville ~ from 8:00 am to 1:00 pm (CST), and in Terre Haute from 9:00 am to 2:00 pm (EST). ALL TIMES STRICTLY OBSERVED.

Local 157 will notify each Member by mail of his/her preferred, but not restricted to, voting location. Any Member voting more than once WILL BE FINED \$5,000.00 and face possible expulsion from the United Association. Any Member voting at a location other than their preferred voting site, will be classified as a contested ballot until all "Eligible to Vote Lists" have been compared and it is determined that the Member has not voted more than once.

11. All voters must be in a designated voting area, as determined by the Election Committee, when they mark their ballots.

12. There is to be no loitering, no smoking, no food or no beverages allowed in the voting area.

13. Handicapped eligible voters may have the assistance of an Election Committee Member in the voting booth, if required.

14. Any tie votes affecting the actual determination of the winner(s) will require a special runoff election which will be held on March 12th, 2016, involving ONLY the candidates and or offices affected.

15. Final determination of the results of the election proceedings will be resolved by the Local Union Election Committee. Any unresolved protest must be filed with the General President of the United Association within five (5) working days following the election in question. A copy of the protest must also be simultaneously served on the Local Union.
