The US Bureau of Labor Statistics for the year 2022, the newest tabulation, reported that 5,486 workers were killed on the job in the United States. No worker should go to work and not return home. With education, training, and regular inspection of workplaces, accidents can be prevented or reduced yet news articles today report increases in accidents in major industries.

To increase awareness of these tragedies, the AFL-CIO in 1989 declared April 28 "Workers Memorial Day" to honor the hundreds of thousands of workers who lost their lives or were injured or disabled at work. The date was chosen to recognize the day in 1970 when the Occupational Safety and Health Act went into effect.

Since that time, Workers Memorial Day events have spread all over the cities and counties of the United States and it has grown to become an international event. This year, on April 28, 2024, Terre Haute joined for the first time the legions of days of remembrance around the world. It was held on the lawn of the house of Eugene V. Debs who was a fervent advocate for workers' safety. The event was reported on local media.

To continue the tradition, union leaders of the building trades, along with representatives of the Greater Terre Haute NAACP Branch #3068 and the Debs Foundation, have already started planning for the second Workers Memorial Day event to be held on Sunday, April 27, 2025, from 2:30-3:30 at the Debs House at 451 North 8th Street. The entire Greater Terre Haute community is invited and encouraged to attend. All union locals in the area are gathering names of fallen workers to be read in a solemn service. We are determined that their sacrifice will not be forgotten.

Business Agent's Report Jon Wooten

I hope everyone had a great Thanksgiving and Christmas with their families. 2024 has been a very busy year and 2025 looks to provide even more work for our membership. Looking over the numbers, Local 157 should just go over 1.4 million manhours for 2024 on building trades projects. With the current projects on the horizon, we should go over that number in 2025.

This Fall Senco at Marathon Oil Refinery has had steady call outs for combo welders and certified riggers. It's encouraging that we have filled all these calls with minimal travelers. Marathon has provided Local 157's membership with more manhours than any other facility in our Local's 125+ year history. Filling those calls for Senco is one of our top priorities. We will fill these calls by whatever means necessary. Whether it be gate testing our AWP students

and using them as combo welders, calling all of our sister locals and putting travelers to work or reaching across the trades and putting other union members to work. We ask that all of our journeymen on site at Marathon be patient and take these AWP students/apprentices under your wing and train our future leaders of 157. We are closely monitoring the number of apprentices to journeymen and as I reported at the December union meeting, we will only be sending journeymen fitters and welders for the foreseeable future.

The loan from the Department of Energy for Entek's lithium separator facility has been issued to the owners. Phase 1 of this project is in full swing and a small crew from Local 157 is on site. Pre-cast walls have been stood up and the rooftop HVAC equipment has arrived. Freitag and Sycamore have both been awarded contracts on the initial shell and core. As the 3D models are coming out the amount of upcoming work for the process systems will be substantial. As these contracts are awarded and pre-jobs are held at our local building trades meetings we will report on them.

Work in the Northern jurisdiction remains steady at ZL9, Wade Utilities and the Rolls Royce project. Freitag has been awarded a process package at Rolls that will include 1" heavy wall stainless 36" od and up. This project will start on 5-10's and last throughout the Summer. BMWC will stay busy in 2025 with their crew at Rolls Royce. A&R Mechanical is finishing up their scope of work at Rolls Royce and should be able to keep everyone on the payroll as the Hillenbrand project will be taking off very soon. As the cold weather moves in, Hillenbrand has fallen behind by 8-10 weeks due to site work and the concrete on the high-rise towers. I look for A&R to add 20+ hands there in the new year. DA Dodd has picked up a contract from GC Tonn and Blank in West Lafayette at the new Ortho Indy facility. That will keep a small crew busy throughout 2025. HMH has 15/20 hands working in the Lafayette area on projects at SIA, IU Hospital and Purdue. Shambaugh has a crew at REA Wire in Lafayette and will stay busy there throughout the winter.

In closing, please continue to utilize our training department and upgrade your welding skills. If you're a fitter pick up your EPRI rigging certification, a state plumbing license or med gas certification. All these certifications will make you more employable. Happy New Year to you all.

Field Representative's Report Adam Bennett

Brothers and sisters, I hope everyone had a Happy Thanksgiving and was able to spend time with their families. That being said I would like to take the time to wish all of you a Merry Christmas!

2025 is looking to be a good year for all of us at Local 157. As of the writing of this article work in Danville is steady with a small upcoming project at their bio diesel plant where they will be needing a combo welder and possibly and apprentice for some long term work and also a short shut down. Speaking with a couple of our contractors in the area they seem to be busy and optimistic about the outlook of work for 2025.

Spring outage work seems to be promising with scheduled shutdowns at Nipsco in West Terre Haute and an outage also scheduled at Duke Energy Cayuga. The need for combo welders and certified riggers will be at a premium, so with the slow down of local jobs this winter there's no better time to utilize our training facility to further your certifications. Speaking of Cayuga we have received word that Kiewit was awarded the bid for a HRSIG boiler job there scheduled to start in late 2025 or early 2026. This project and another project there is something we will be reporting on as more details come this year.

As with every election year, there are a lot of questions regarding upcoming projects with a new incoming President. Recently I was able to sit down with Pete Rimsans, Vice President of government relations at Wabash Valley Resources. (For-

merly S&G Solutions). Pete was very optimistic about the state of work at WVR and stressed the fact that the job was still on track to be underway in early 2025. This is a large scale long term project that we will be reporting heavily on until we have boots on the ground.

In closing, as we look into 2025 it seems that some of these projects are finally coming to fruition and we are on track for a big year! I would personally like to wish every one of you a happy, safe and prosperous New Year!

Financial Secretary/Treasurer's Report Todd Boland

I'm writing this as we close out the year 2024. My hope is for everyone to have a safe, healthy and prosperous 2025. Our forecast for employment in the upcoming 2025 year looks as promising as any time during my career.

Industrial Supply has terminated their relationship with Local 157. The employees that we represent have voted to move in a different direction. They have decided to become an employee-owned business. We only represented 5 of their employees in 2024 and have communicated to those employees that they still have an option to remain members. If they choose to remain with UA Local 157, they would be evaluated through the training department and

placed in the apprenticeship program based on their assessment and skill level. Industrial Supply has been with Local 157 since the early 1950's.

Gas Distribution hours reported for the last 3 months are as follows: September 19,489; October 23,106 and November 18,996 hours. All in all, these are impressive numbers. A big thank you to Tom Gofourth for continuing his organizing efforts. During the last week of December, Tom organized 2 new members in Kentucky. Tom has also been busy with lead pipe replacement throughout Indiana and Kentucky. The contractors being utilized for this work does not only include those Gas Distribution Contractors but also includes Building Trades Licensed Plumbers. Tom was instrumental in getting municipal contract language amended in the City of Lafayette, which requires the use of Licensed Plumbers. This is one of those many reasons why we need to have representation in those municipal conversations. Thanks to Tom for your work on these things.

Currently Barry Turner, Tom Gofourth and I are involved with helping the local Eugene V. Debs Foundation establish a Workers Memorial. We've been asked to create a list of members who were disabled or lost their lives while on the job. This list will include those commuting to and from work. We've obtained useful information provided by our local Historian, Mitch Poynter. If you know anyone that should be included in this memorial, please notify one of us.

During my last report, I discussed the opportunity for remote meetings. To briefly update this, there was a motion made during our October meeting to form a committee to investigate our options. Troy had already contacted Sycamore Engineering. The motion passed and the wheels are turning. Thanks to Troy for the vision and to Adam for getting this started. This has been something our members have talked about for a long time, I'm excited to see this moving in the right direction.

I receive a lot of questions regarding options for payment of Union Dues. There are several convenient options available. 1) Automatic payment can be set up through your personal banking institution. 2) Checks can be mailed to or dropped off at the hall. 3) Dues can be paid through our secure Members Site. 4) Payment can be accepted via telephone. I understand everyone is busy and life gets in the way. Per our bylaws, Sec 29, Unions Dues are to be paid by the first day of each quarter. Please call if you have any questions or need assistance setting up auto payment.

By now, everyone should have received a letter regarding the newly implemented Peer Mentoring Group. This is very personal to me, and I would like to say a special thanks to all those involved in making this available to our members. As a person with nearly 24 years in long term recovery, I know the struggles that come with needing to ask for help. I'm actively involved in the recovery community and have resources with Mental Health America, Wabash Valley Recovery Alliance as well as suicide prevention. During the months of October, November, and December 2024, your Health & Welfare Plan staff processed 27,425 claims, totaling \$12,416,849.89.

With the start of a new year underway, I would like to remind you of the current deductible and out of pocket limits that renew each January 1st. The current deductible is \$700.00 per person per calendar year with a family maximum of \$2,100.00. Please keep in mind, one person cannot meet more than the individual deductible towards the family maximum. The annual out of pocket per person per calendar year is \$4,000.00 with a family maximum of \$8,000.00. Again, one person cannot meet more than the individual limit.

Remember, one way to save some out-of-pocket costs is to utilize the FREE and easy to use LiveHealth Online service your plan offers all eligible members and dependents not entitled to Medicare or other primary group coverage. The service is available 24 hours a day, 7 days a week, 365 days a year and can be accessed from any smartphone or computer with webcam capabilities. You will find the app in your smartphone's App Store. If you already have the App, please make sure you have updated your insurance identification number so that they can find your eligibility and bill correctly. Every dependent over the age of 18 will need to set up their own account. If you should be charged for your LiveHealth visit, please contact this office so that we may assist you.
